A US Navy Gunner's Mate is a sailor who specializes in the operation, maintenance, and repair of different types of firearms on board ships / They are responsible for the operation and maintenance of guided missile launching systems, gun mounts, and other ordnance equipment, as well as small arms and magazines / The primary responsibility of a Gunners Mate is to maintain various types of large-caliber weapons systems on naval ships such as cannons, machine guns or torpedoes / Besides maintaining these weapon systems they are also responsible for storing and issuing ammunition as required / A gunnery mate may also be assigned with the task of operating any type or caliber gun on-board / During training sessions or live operations they could work with deck crews to coordinate firing solutions while keeping track targets using radar equipment installed below decks

USS Newport News (CA-148) was the third and last ship of the Des Moines-class of heavy cruisers / She was the

first fully air-conditioned surface ship and the last all-gun heavy cruiser in the United States Navy / The Newport News was commissioned on 29 January 1949 and was deployed to the Mediterranean from 1950 to 1961 for duty with the Sixth Fleet / Operations from 1963 through 1967 consisted primarily of NATO exercises in the North Atlantic, gunnery and amphibious exercises off the Eastern seaboard and Caribbean, and midshipman cruises / On 5 September 1967, the Newport News departed for a six-month deployment to Southeast Asia / Arriving in Da Nang, South Vietnam, she fired her eight-inch guns for the first time against shore targets in North Vietnam as part of Operation Sea Dragon / Newport News spent 50 days patrolling the coast of North Vietnam as part of Operation Sea Dragon – the Navy's effort to destroy waterborne logistics craft, military supply routes and installations in North Vietnam / During this period, the ship conducted 156 strikes with 325 North Vietnamese coastal defense sites taken under fire / According to spotters, Newport News sank 17 waterborne logistics craft, damaged another 14 and destroyed several enemy bunkers and radar sites, bridges, barges, trucks and roads / The ship was subjected to return fire on several occasions, but each time countered enemy batteries / On 19 December 1967, Newport News exchanged fire with 20–28 separate shore batteries, simultaneously, off the coast of North Vietnam / During this engagement, over 300 enemy rounds bracketed the cruiser's position, but she suffered no direct hits / This encounter led to forward observers to nickname Newport News "The Gray Ghost from the East Coast," a moniker she retained throughout her three Vietnam deployments / Newport News was decommissioned on 27 June 1975 and stricken from the Naval Vessel Register on 31 July 1978 / She spent her later years as a member of the Philadelphia Naval Shipyard's Mothball Fleet and was sold for scrap in New Orleans, Louisiana, on 25 February 1993

The Vietnam Service Medal is a military award of the United States Armed Forces established on 8 July 1965 by order of President Lyndon B. Johnson / The medal is awarded to recognize service during the Vietnam War by all members of the U.S. Armed Forces provided they meet the award requirements / Service stars were awarded to all services for participation in designated campaigns

The Republic of Vietnam Campaign Medal, also known as the Vietnam Campaign Medal is a South Vietnamese military campaign awarded during the Vietnam War (Second Indochina War), the South Vietnamese government awarded the Republic of Vietnam Campaign Medal with Device (1960–) to members of the U.S. military for support of operations in Vietnam In May 1966 / The medal was awarded for two different periods of service in Vietnam / The first period for the award was from 8 March 1949 to 20 July 1954 / The second period was from 1 January 1960 to the end of the Vietnam War

The Navy Meritorious Unit Commendation (MUC) is a unit award of the United States Navy presented to U.S. Navy and Marine Corps units / The award is presented for service that is performed with character that would be comparable to the Bronze Star Medal / The Navy Meritorious Unit Commendation is awarded to any unit of the Navy or Marine Corps that has distinguished itself, under combat or non-combat conditions, by either valorous or meritorious achievement, which renders the unit outstanding compared to other units performing similar service, but not sufficient to justify award of the Navy Unit Commendation / To justify this award, the unit must have performed service of a character comparable to that which would merit the award of a Bronze Star Medal, or achievement of like caliber in a non-combat situation, to an individual / Additional awards are represented by wearing a Bronze Star device on the service ribbon

The National Defense Service Medal (NDSM) is a service award of the United States Armed Forces established by President Dwight D. Eisenhower in 1953 / It is awarded to every member of the US Armed Forces who has

Staff Sergeant Roger Thomas Lagodzinski honorably served in the United States Army / SSGT Roger Lagodzinski was deployed to Vietnam on 5 December 1968 as a Light Weapons Infantryman / SSG Roger Lagodzinski was Killed In Action on 19 May 1970 when an enemy booby trap exploded in Thua Thien Province, South Vietnam

SSG Roger Lagodzinski was on a Mission with an L Co. Ranger Team on 19 May 1970 / SSGT Lagodzinski stepped on a booby trap and was medevacked out / In the Phu Bai Evac, the doctors thought that they had stabilized him but did not realize that an artery was bleeding internally and SSG Roger Lagodzinski subsequently died

SSG Roger Lagodzinski was awarded the Silver Star for conspicuous gallantry and intrepidity in action on the battlefield

Base Assignments:

Fort Dix - Trenton, New Jersey - Fort Dix was established in 1917 and named for Major General John Adams Dix, a veteran of the War of 1812 and the Civil War / Dix served as a training and staging ground during World War II and a demobilization center after the war / Ten divisions and many smaller units trained and staged here before entering the battlefields of World War II / At the end of the war, the reception center became the separation center, returning more than 1.2 million Soldiers to civilian life

Roger Lagodzinski attended John F. Kennedy High School in Sloan before joining the U.S. Army during his Senior year / Roger Thomas Lagodzinski was 22 years old at the time of his passing and is interred at Saint Stanislaus Roman Catholic Cemetery, Cheektowaga, New York

Roger Thomas Lagodzinski is honored on the Vietnam Veteran's Memorial in Washington D.C. - Name inscribed at VVM Wall, Panel 10w, Line 65

Light Weapons Infantryman lack heavy weapons and armor or with a reduced vehicle footprint / Light infantry units lack the greater firepower, operational mobility and protection of mechanized or armored units, but possess greater tactical mobility and the ability to execute missions in severely restrictive terrain and in areas where weather makes vehicular mobility difficult / Light infantry forces typically rely on their ability to operate under restrictive conditions, surprise, violence of action, training, stealth, field craft, and fitness levels of the individual soldiers to compensate for their reduced lethality / Despite the usage of the term "light", forces in a light unit must carry everything they require to fight, survive and win due to lack of vehicles

The 101st Airborne Division (Air Assault) ("Screaming Eagles") is a light infantry division of the United States Army that specializes in air assault operations / It can plan, coordinate, and execute multiple battalion-size air assault operations to seize terrain / These operations can be conducted by mobile teams covering large distances, fighting behind enemy lines, and working in austere environments with limited or degraded infrastructure / Established in 1918, the 101st Division was first constituted as an airborne unit in 1942 / During World War II, it gained renown for its role in Operation Overlord (the D-Day landings and airborne landings on 6 June 1944, in Normandy, France); Operation Market Garden; the liberation of the Netherlands; and its action during the Battle of the Bulge / From 1965 to 1967, the 1st Brigade operated independently as sort of a fire brigade and earned the reputation as being called the "Nomads of Vietnam" / They fought in every area of South Vietnam from the Demilitarized Zone up north all the way down the Central Highlands / The rest of the 101st was deployed to Vietnam in November 1967 and the 1st Brigade rejoined its parent division / The 101st was deployed in the northern I Corps region, operating against the People's Army of Vietnam (PAVN) infiltration routes through Laos and the A Shau Valley for most of the war / Notable among these were the Battle of Hamburger Hill in 1969 and Firebase Ripcord in 1970 / The division began withdrawing from South Vietnam on 15 May 1971 with the departure of the 3rd Battalion, 506th Infantry / Most major units of the Division had redeployed by January 1972 / In the seven years that all or part of the division served in Vietnam, it suffered 4,011 killed and 18,259 wounded in action / The division, during this time, participated in 12 separate campaigns and 17 of the division's Medal of Honor recipients are from this period of time – all this giving the 101st Airborne Division a combat record unmatched by any other division

The Silver Star Medal (SSM) is the United States Armed Forces' third-highest military decoration for valor in combat / The Silver Star Medal is awarded primarily to members of the United States Armed Forces for gallantry in action against an enemy of the United States / The gallantry displayed must have taken place while in action against an enemy of the United States, while engaged in military operations involving conflict with an opposing foreign force

The Bronze Star Medal (BSM) is a is the fourth-highest individual military award and the ninth-highest by order of precedence in the United States Armed Forces / The Bronze Star is awarded to members of the United States

Armed Forces for either heroic achievement, heroic service, meritorious achievement, or meritorious service in a combat zone / When the medal is awarded by the Army and Air Force for acts of valor in combat, the "V" Device is authorized for wear on the medal

The Air Medal (AM) is a military decoration of the United States Armed Forces / It was created in 1942 and is awarded for single acts of heroism or meritorious achievement while participating in aerial flight

The Purple Heart was instituted in 1782 by George Washington and is the first and oldest military American decoration / The Purple Heart is awarded to military service members wounded or killed in action, in the latter case posthumously

The Combat Infantryman Badge (CIB) is a United States Army military decoration. The Army's Basic Parachutist Badge is awarded to all military personnel of any service who complete the US Army Basic Airborne Course at Fort Benning, Georgia / It signifies that the soldier is a trained military parachutist, and is qualified to participate in airborne operations

A Marksmanship Badge is a U.S. military badge or a civilian badge which is awarded to personnel upon successful completion of a weapons qualification course (known as marksmanship qualification badges) or high achievement in an official marksmanship competition (known as marksmanship competition badges) / The U.S. Army and the U.S. Marine Corps are the only military services that award marksmanship qualification badges / The U.S. military marksmanship qualification badges are awarded in three grades (highest to lowest): expert, sharpshooter, and marksman while their marksmanship competition badges are awarded in three to four grades (highest to lowest): distinguished, silver, and bronze for the U.S. Army and distinguished, gold, silver, and bronze for the Marine Corps

The Presidential Unit Citation, originally called the Distinguished Unit Citation, is awarded to units of the United States Armed Forces for extraordinary heroism in action against an armed enemy on or after 7 December 1941

REPUBLIC OF VIETNAM GALLANTRY CROSS MEDAL

The Republic of Vietnam Gallantry Cross Medal, also known as the Vietnamese Gallantry Cross or Vietnam Cross of Gallantry is a military decoration of the former Government of South Vietnam (Republic of Vietnam) / The medal was created on August 15, 1950 and was awarded to military personnel, civilians, and Armed Forces units and organizations in recognition of deeds of valor or heroic conduct while in combat with the enemy / Individuals who received the medal, ribbon, and a citation were personally cited at the Armed Forces, Corps, Division, Brigade or Regiment level / The United States military began authorizing the Republic of Vietnam Gallantry Cross in March 1968 with retroactive presentation of the decoration to 1961

NATIONAL DEFENSE SERVICE MEDAL

The National Defense Service Medal (NDSM) is a service award of the United States Armed Forces established by President Dwight D. Eisenhower in 1953 / It is awarded to every member of the US Armed Forces who has served during any one of four specified periods of armed conflict or national emergency from 1950 to the present / Combat or "in theater" service is not a requirement for the award

GOOD CONDUCT MEDAL

The Good Conduct Medal is one of the oldest military awards of the United States Armed Forces / The U.S. Navy's variant of the Good Conduct Medal was established in 1869, the Marine Corps version in 1896, the Coast Guard version in 1923, the Army version in 1941, and the Air Force version in 1963 / The Good Conduct Medal is awarded to any active duty enlisted member of the United States military who completes three consecutive years of "honorable and faithful service" / Such service implies that a standard enlistment was completed without any non-judicial punishment, disciplinary infractions, or court martial offenses

Sergeant Charles Michael Lamby honorably served in the United States Army / SGT Charles Lamby was deployed to Vietnam on 9 November 1968 as a Light Weapons Infantryman / SGT Charles Lamby was Killed In Action on 30 March 1969 from multiple fragmentation wounds suffered in combat action in Kontum Province, South Vietnam

On 30 March 1969, "A" Company encountered and engaged a hostile enemy force in Kon Tum Province / During the battle, sixteen men were killed and many more were wounded / SGT Charles Lamby was one of the casualties, killed by shrapnel wounds from a hostile explosive device

Sergeant Charles Lamby attended the Non-Commissioned Officers School at Ft. Benning, Georgia

Base Assignments:

Fort Jackson , South Carolina - Fort Jackson is a United States Army installation, which the United States Army Training and Doctrine Command (TRADOC) operates for Basic Combat Training (BCT), and is located within the city of Columbia, South Carolina / Fort Jackson was created in 1917 and named for Andrew Jackson, a United States Army general and the seventh president of the United States (1829–1837) who was born in the border region of North and South Carolina / Fort Jackson is the largest and most active initial entry training center in the U.S. Army, training 50 percent of all soldiers entering the Army each year / Providing the Army with new soldiers is the post's primary mission / 35,000 potential soldiers attend basic training and 8,000 advanced individual training soldiers train at Fort Jackson annually

Ft. Benning, Georgia - Fort Benning is a United States Army post straddling the Alabama–Georgia border next to Columbus, Georgia and is named after Henry L. Benning, a brigadier general in the Confederate States Army during the Civil War/ Fort Benning supports more than 120,000 active-duty military, family members, reserve component soldiers, retirees and civilian employees on a daily basis / Since 1909, Fort Benning has served as the Home of the Infantry / Fort Benning is one of ten U.S. Army installations named for former Confederate generals / The congressionally mandated Naming Commission has recommended it be renamed Fort Moore after Lieutenant General Hal and Julia Moore

Charles Lamby was a graduate of Lake Shore Central School / Lamby was a graduate of Mohawk Valley Community College and attended the University of Buffalo before entering the U.S. Army in 1967 / Charles Michael Lamby was 23 years old at the time of his passing and is interred at Saint Vincent de Paul Cemetery, North Evans, New York

The 4th Infantry Division is a division of the United States Army based at Fort Carson, Colorado / The division was first activated in 1917 and has served in World War I, World War II, Vietnam War, Operation Iraqi Freedom, and Operation Enduring Freedom1 / The 3rd Battalion, 12th Infantry is a battalion of the United States Army and assigned to the 4th Infantry Division, currently stationed at Fort Carson, Colorado

The 12th Infantry Regiment is a unit of the United States Army / Three 12th Infantry battalions deployed to South Vietnam with the 4th Division from August through October 1966 / The 3rd Brigade, 4th Division, to which the 2nd Battalion, 12th Infantry was assigned, set up base camp at Dau Tieng in III Corps while the rest of the 4th Division was assigned to the Central Highlands in II Corps alongside the 3rd Brigade of the 25th Division which had arrived in December 1965 / The 1st and 3rd Battalions returned in December 1970 with the 4th Division to

Specialist Fourth-Class David Henry Lassen honorably served in the United States Army / SP4 David Lassen was deployed to Vietnam 10 June 1969 as a Field Wireman / SP4 David Lassen was Killed In Action on 1 April 1970 from multiple fragmentation wounds he sustained by hostile mortar or rocket fire at Firebase (Fsb) Illingsworth, Tay Ninh Province, South Vietnam

Fire Support Base Illingsworth was a U.S. Army firebase located twenty-one miles northwest of Tay Ninh, approximately three miles from the Cambodian border / On 1 April 1970, the base was occupied by Companies "C" and "E", 2nd Battalion, 8th Cavalry; "B" Battery, 5th Battalion, 2nd Artillery; "A" Battery, 1st Battalion, 30th Artillery; "A" Battery, 2nd Battalion, 32nd Artillery; and "B" Battery, 1st Battalion, 77th Artillery, comprising roughly 220 men / Ground surveillance radar detected strong movement outside the perimeter right before midnight, and at approximately 2:17 AM the North Vietnamese Army began pounding the base with over 300 rounds of mixed 122mm and 107mm rockets, 120mm, 82mm, and 60mm mortars, and 75mm recoilless rifle and B-40 rocket-propelled grenade rounds / Firebase Illingsworth was then assaulted by a force of over 400 troops from the southwest / The enemy was engaged with unit weapons, artillery, aerial rocket artillery, night-illuminated "Nighthawk" attack helicopter sorties, and other air support / Fighting was fierce, particularly on the southwest portion of the firebase where friendly forces engaged the enemy in hand-to-hand combat in order to repel the assault / During the attack, an ammunition dump containing over 190 rounds of 8" ammunition exploded in a tremendous blast, destroying an 8" artillery gun and damaging radio antennas, rendering a temporary loss of communication / At 3:30 AM, the base was still receiving mortar and rocket fire although the

Corporal Kenneth John LeCastre honorably served in the United States Marine Corps / CPL Kenneth LeCastre was deployed to Vietnam as an Anti-Tank Assaultman / CPL Kenneth LeCastre was Killed In Action on 9 May 1967 from enemy small arms fire during combat operations around Hill 778 Khe Sanh, Quang Tri Province, South Vietnam

On 9 May 1967, Company "F" engaged a large enemy force in the mountainous area west of Hill 778 near Lang Xoa 11 kilometers west of the Khe Sanh Combat Base / The Marine walked into a NVA base camp that was taking heavy fire / Company "E" was on Hill 803 overlooking the battle and began to provide 81mm mortar support, however the effect was minimal because of the heavy tree cover / Helicopter gunships and fixed wing aircraft arrived in support / The engagement lasted throughout the day with twenty men from Company "F" being killed in the action and more being wounded / One of the casualties was Cpl Kenneth LeCastre, who was killed in action by hostile rifle fire

The Battle of Khe Sanh was conducted in northwestern Quang Tri Province, South Vietnam with roots in 1967, and extending viciously throughout 1968 / It was the longest, deadliest and most controversial battle of the Vietnam War / During the battle, a massive aerial bombardment campaign (Operation Niagara) was launched by the United States with over 100,000 tons of bombs / Five tons of bombs for every one of the 20,000 NVA soldiers in the fight / President Johnson was determined to hold Khe Sanh at all costs / The jungles surrounding

Khe Sanh were burned and bombed barren and Khe Sanh became the major news headline coming out of Vietnam in late March 1968 / The cost on American lives lost has been estimated to be around 1000, with NVA loses ten times that number

An Anti-tank Assaultman was a front-line military job that supported ground infantry and tasked with tankbusting and breaching / In the past, Marine Corps Infantry Assault had been referred to as "grunts" for their hard, grueling work in combat / Assaultman were responsible for anti-armor operations and tactical vehicle operations / These servicemembers provided medium and heavy anti-armor fire in support of the infantry battalion

9th Marine Amphibious Brigade (9th MAB) was a United States Marine Corps unit / Following the Gulf of Tonkin Incident in August 1964, the 9th Marine Expeditionary Brigade (9th MEB) was activated / It consisted of 9th Marine Regiment regimental headquarters and three battalion landing teams (BLT) / Almost 6,000 men were transformed into an effective force in readiness / The 9th Marine Expeditionary Brigade (9th MEB) was deactivated on 6 May 1965 and reactivated on 1 March 1966 as 9th Marine Amphibious Brigade (9th MAB) on Okinawa, Japan and landed in Vietnam on 8 March 1965 / the 9th MAB participated in Operation Osage in South Vietnam between 27 April and 3 May 1966 / The 9th MAB was assigned to the mission of destroying a VC battalion and elements of a People's Army of Vietnam (PAVN) regiment reported to be operating in Thừa Thiên-Huế Province / The 9th MAB provided Battalion Landing Team (BLT) of 1st Battalion, 26th Marines for Operation Deckhouse IV from 15–18 September 1966 / The 9th MAB's Marines killed over 200 PAVN soldiers from 90th Regiment with the loss of 36 Marines / During the rest of the year, the 9th MAB and its units were stationed off the northern coast of South Vietnam in order to provide force for the defense of Vietnam Demilitarized Zone in case of emergency / The 9th MAB launched the Operation Deckhouse VI on 16 February 1967 in order to disrupt enemy movement in the vicinity of Sa Huynh salt flats, search northward in the Nui Dat area, and, finally, link up with the 3rd Battalion, 7th Marines, then operating around Nui Dat in Operation Desoto / The 9th MAB took part in the Operation Beaver Cage between 28 April and 13 May 1967 and Operation Dewey Canyon / In 1969, it was announced that the regiment would be part of the 25,000 man withdrawal from Vietnam, ending more than four years of combat actions in Vietnam for the 9th Marines

2nd Battalion, 3rd Marines (2/3) was an infantry battalion in the United States Marine Corps based out of Marine Corps Base Hawaii consisting of approximately 1,000 Marines and sailors / The battalion fell under the command of the 3rd Marine Regiment and the 3rd Marine Division / In January 1961, 2/3 was redeployed to Camp Schwab, Okinawa, and reassigned to 3d Marine Division, Fleet Marine Force / From there the unit deployed at various times between 1961 and 1967 as the Battalion Landing Team of the Seventh Fleet / In April

United States Naval Construction Battalions, better known as the Navy Seabees, form the U.S. Naval Construction Force (NCF) / Naval Construction Battalions were conceived of as replacements for civilian construction companies in combat zones after the attack on Pearl Harbor / At the time civilian contractors had roughly 70,000 men working U.S. Navy contracts overseas / International law made it illegal for civilian workers to resist an attack and by doing so would classify them as guerrillas and could lead to summary execution / With roots dating back to World War II, the Seabees were formally established on 5 March 1942, to meet the Navy's growing need to construct bases, build airfields, conduct underwater construction and build roads, bridges and other support facilities while providing protection for themselves and those around them as part of the war effort / The Seabees were deployed to Vietnam twice in the 1950s to survey and map the roads / Seabee teams (501 and 502) arrived in January 1963 as the first Seabees of the Vietnam War / The last battalion withdrew late 1971 with the last Seabee teams out a year later / When it was over, 137 Seabee teams were sent to Vietnam and had built 15 CB camps and deployed 22 battalions / In the over seven decades since its founding, Seabees have gone on to serve in most major U.S. conflicts

The Republic of Vietnam Gallantry Cross Medal, also known as the Vietnamese Gallantry Cross or Vietnam Cross of Gallantry is a military decoration of the former Government of South Vietnam (Republic of Vietnam) / The medal was created on August 15, 1950 and was awarded to military personnel, civilians, and Armed Forces units and organizations in recognition of deeds of valor or heroic conduct while in combat with the enemy / Individuals who received the medal, ribbon, and a citation were personally cited at the Armed Forces, Corps, Division, Brigade or Regiment level / The United States military began authorizing the Republic of Vietnam Gallantry Cross in March 1968 with retroactive presentation of the decoration to 1961 / Gallantry Cross with Palm: cited at the Armed Forces level

The Legion of Merit Medal is conferred on officers and enlisted men of the armed forces of the United States and on nationals of other countries who have distinguished themselves by exceptionally meritorious conduct in the performance of outstanding services since Sept. 8, 1939, the date of the president's proclamation of the state of emergency that led to World War II / The Legion of Merit may be awarded for combat or noncombat services; in the case of American military personnel, if the award is for combat service it is shown by the wearing of a combat V device

The Defense Superior Service Medal (DSSM) is a military decoration of the United States Department of Defense, which is presented to United States Armed Forces service members who perform superior meritorious service in a position of significant responsibility / The decoration is most often presented to general and flag officers, followed by a lesser number of Army, Marine Corps, Air Force, and Space Force colonels and Navy and Coast Guard captains / The medal is presented in the name of the United States Secretary of Defense and was

The Air Force Achievement Medal (AFAM) is a decoration awarded to Air Force personnel for an outstanding achievement or meritorious service not of the same nature that warrants receiving the Commendation medal / The AFAM is only awarded to junior personnel and is most often awarded to officers with the pay grade of O-4 and below, as well as enlisted personnel below the grade of E-7 / The AFAM can be given in an area of combat but only for non-combat meritorious service and it is considered to be the lower of the U.S. Military's meritorious service medals / The Air Force Achievement medal acknowledges the contributions of the junior officers and enlisted personnel who are not eligible to receive the higher Commendation medal or the Meritorious Service Medal.

Specialist Fourth-Class John Joseph Levulis honorably served in the United States Army / SP4 John Levulis was deployed to Vietnam on 8 March 1970 as a Medical NCO (Combat Medic) / SP4 John Levulis died on 21 February 1971 from injuries sustained in the non-hostile related crash of the helicopter in which he was not a crew member in Quang Tri Province, South Vietnam / All crew and passengers suffered mortal injuries, SP4 John Levulis was one of the casualties

At approximately 2150 hours on 20 February 1971, WO1 John V. Rauen (Dustoff 30) and his crew from the 498th Medical Company (Air Ambulance) were notified of an extended mission in support of armed operations west of Khe Sanh Airfield / At this time WO1 Rauen elected to refuel his aircraft, a U.S. Army helicopter UH-1H (tail number 69-15273), and the tower cleared him to reposition from B-Med to POL (refueling station) / The aircraft was flown to POL and refueled without incident / Khe Sanh tower was again contacted, and Dustoff 30 was cleared from POL back to B-Med / Dustoff 30 departed to the north, and after obtaining a height of 60-80 feet, the aircraft was turned to a southwesterly heading / Upon reaching the approach end of Runway 09, the aircraft was seen to enter a fog bank which partially obscured the running lights and rotating beacon / Witnesses stated ground fog had been moving in and out of the area, causing the horizontal visibility to vary from zero-zero to unlimited / Shortly after the aircraft entered the fog, a hard turn left was observed by witnesses standing on the approach end of Runway 09 / Witnesses further stated they saw the aircraft losing altitude during the steep turn / No power loss or malfunction of the engine was noted / As the aircraft neared

the ground, the aircraft commander apparently realized what was happening and flared the aircraft in an attempt to decrease his rate of descent / The aircraft impacted the ground (aft left skid), descending at a rate of 650 feet per minute / The aircraft continued forward, flying approximately 45 feet then made ground contact a second time where the right skid made a furrow in the ground / As the right skid collapsed, the main rotor blade made contact with two fifty-five (55) gallon drums / The aircraft continued forward, and a Nomex flight suit sleeve was torn off one of the crew members by a jagged edge from one of the two fifty-five gallon drums / Also, at this point the head separated from the main rotor mast and as the aircraft began to roll, the tailboom separated from the main fuselage / The fuselage rolled another 250 feet leaving puddles of burning JP-4 fuel, and came to rest in the upright position facing north / The tailboom also continued forward coming to rest ninety feet NW of the fuselage / The aircraft commander, WO1 John M. Souther (left seat), was completely engulfed in flames, and therefore was not removed until the fire was at least partially extinguished / The pilot, WO1 Rauen, was extracted from the main fuselage with the use of a front loader / He died 26 February 1971, from 3rd degree burns of the head and shoulders / The crew chief, SP4 Dennis E. Gilliland, was thrown clear of the main fuselage and landed near the tailboom / He died enroute from Khe Sanh to Quang Tri from 3rd degree burns over ninety percent of his body / The medic, SP4 John J. Levulis, was extracted from the right side of the cargo compartment critically burned / Specialist Fourth-Class John Levulis died on 21 February 1971

Specialist Four-Class John Joseph Levulis was awarded the Distinguished Flying Cross for his heroism and extraordinary achievement while engaged in aerial flight

The 61st Medical Battalion (Area Support) provided Level I and II Combat Health Support and medical evacuation to III Corps units and other units including joint services as required; be prepared to rapidly reinforce/replace standard medical modules to division-level units; augment medical units with field surgical support; and provide combat stress control, preventive medicine, optometry and dental services to III Corps personnel / The 61st Medical Battalion was first constituted on 7 August 1942 in the Army of the United States as the 61st Medical Battalion, Motorized and activated on 25 September 1942 at Camp Breckinridge, Kentucky / The Battalion was broken up 9 May 1944 and its elements reorganized and redesignated / Headquarters and Headquarters Detachment was reorganized and redesignated as Headquarters and Headquarters Detachment, 61st Medical Battalion / Companies A, B, and C, and the Clearing Company were reorganized and redesignated as the 391st, 392nd, and 393rd Medical Collecting Companies, and the 643rd Clearing Company, respectively,

each thereafter having separate lineages / The unit participated in the Normandy landings, receiving participation credit for the campaign, including a streamer with arrowhead, indicating participation in the initial assault / The Battalion also participated in the Northern France campaign / It was inactivated on 12 November 1945 in France after the end of the Second World War / The Battalion was allotted on 1 March 1963 to the Regular Army and reactivated on 26 March 1963 at Fort Campbell, Kentucky / The Battalion was later deployed to Vietnam, participating in 14 campaigns of the conflict there: Counteroffensive, Counteroffensive Phase II, Counteroffensive Phase III, Tet Counteroffensive, Counteroffensive Phase IV, Counteroffensive Phase V, Counteroffensive Phase VI, Tet 69/Counteroffensive, Summer-Fall 1969, Winter-Spring 1970, Sanctuary Counteroffensive, Counteroffensive Phase VII, Consolidation I, and Consolidation II / After returning from Vietnam, the unit was inactivated on 18 February 1972 at Fort Lewis, Washington / After the events of 11 September 2001, the Battalion deployed elements in support of both Operation Enduring Freedom in Afghanistan and Operation Iraqi Freedom in Iraq / These elements redeployed back to Fort Hood in August 2004 / In October 2005, the unit cased its colors in preparation for another deployment in support of the Global War on Terror (later termed Overseas Contingency Operations) / In September 2010, the 61st Medical Battalion (Multifunctional) returned from a year-long deployment in Iraq in support of Operation Iraqi Freedom

The 498th Medical Company (AA) was constituted in the Regular Army as Company C, 57th Medical Battalion, on 13 January 1941 and activated on 10 February 1941 at Fort Ord, California / On September 10th 1941, the unit was reorganized and redesignated as the 498th Collecting Company, and after serving in WWII, was inactivated at Camp Shanks, New York on 24 October 1945 / The 498th was redesignated as the 498th Preventive Medicine Company on 11 September 1950 and activated on 2 October of that year at Fort Sam Houston, Texas / The unit was reorganized and rededicated the 498th Medical Company on 19 June 1953 only to be inactivated on 24 September 1956 at Fort Meade, Maryland / On 23 September 1964, the unit was activated as an air ambulance company at Fort Sam Houston, Texas and deployed to Vietnam / Upon return to the states in October 1971 the unit was relocated to Fort Jackson, SC, Fort Stewart, GA and Fort Benning, GA

The Distinguished Flying Cross (DFC) is a military decoration of the United States Armed Forces / The medal was established on July 2, 1926, and is currently awarded to any persons who, after April 6, 1917, distinguish themselves by single acts of heroism or extraordinary achievement while participating in aerial flight / Both heroism and extraordinary achievement are entirely distinctive, involving operations that are not routine

The Air Medal (AM) is a military decoration of the United States Armed Forces / It was created in 1942 and is awarded for single acts of heroism or meritorious achievement while participating in aerial flight

The Purple Heart was instituted in 1782 by George Washington and is the first and oldest military American decoration / The Purple Heart is awarded to military service members wounded or killed in action, in the latter case posthumously

The Republic of Vietnam (RVN) Armed Forces Honor Medal was a military decoration of South Vietnam that was first created on 7 January 1953 / The medal was awarded in two classes and reached its height of bestowal during the Vietnam War / It was frequently awarded to members of foreign militaries, including military advisors of the United States Armed Forces / The Armed Forces Honor Medal was awarded to any member of the military who actively contributed to the formation and organization of the Vietnamese military in South Vietnam and who actively participating in cadre training of Vietnamese units / It was intended for non-combat achievements / The first-class medal was awarded to commissioned officers and the second class medals were awarded to warrant officers and enlisted personnel

The Combat Medical Badge is an award of the United States Army which was first created in January 1945 / Any member of the Army Medical Department, at the rank of colonel or below, who is assigned or attached to a ground combat arms unit of brigade or smaller size which provides medical support during any period in which the unit was engaged in ground combat is eligible for the CMB / According to the award criterion, the individual must be performing medical duties while simultaneously being engaged by the enemy

The Presidential Unit Citation, originally called the Distinguished Unit Citation, is awarded to units of the United States Armed Forces for extraordinary heroism in action against an armed enemy on or after 7 December 1941

L'Huillier was on a strike mission flying F-100 #54-1912 near Thon Sau, 15km S-SE of Heip Duc, South Vietnam / L'Huillier was fatally injured after he ejected from his disabled aircraft west of Chu Lai. Immediately after a high angle dive bomb delivery / Captain L'Huillier's aircraft was believed to have been hit by ground fire / Captain L'Huillier relayed that his aircraft controls were failing and then pulled up into a cloud deck and ejected / No one observed his ejection but his parachute was spotted on the ground a short while later / A rescue helicopter picked him up within 30 minutes, but he died before he could be hospitalized / His fatal injuries were probably incurred upon ejection or landing, with improper chute opening or seat involvement suspected

Captain Joseph L'Huillier enlisted in the Air Force, arrived at the Niagara Falls Air Base as a helicopter pilot and became a jet fighter pilot flying F-100 Aircraft for four years / CAPT L'Huillier accepted a commission in the Air Force about a month before the departure of the 107th Tactical Fighter Group to Vietnam in May 1968

The Seventh Air Force (Air Forces Korea) (7 AF) is a Numbered Air Force of the United States Pacific Air Forces (PACAF) / It is headquartered at Osan Air Base, South Korea / The command's mission is to plan and direct air component operations in the Republic of Korea and in the Northwest Pacific / Established on 19 October 1940 as the Hawaiian Air Force at Fort Shafter, Territory of Hawaii, the 7 AF was a United States Army Air Forces combat unit in the Pacific Theater of World War II, providing air defense of the Hawaiian Islands and engaging in combat operations primarily in the Central Pacific AOR / It was assigned units engaging enemy forces in the Gilbert Islands; Marshall Islands; Caroline Islands; Mariana Islands, and in the last major battle of the Pacific War, the Battle of Okinawa / On 28 March 1966, Seventh Air Force was designated a combat command at Tan Son Nhut Air Base, overseeing the operations of the ten primary USAF bases in the Republic of Vietnam / From April 1966 until 1973, the command assumed responsibility for most Air Force operations in Vietnam and shared responsibility with the Thirteenth Air Force for operations conducted from Thailand as 7/13 Air Force / In June 1966, the first US air attacks near Hanoi and Haiphong occurred when 7AF planes bombed nearby oil installations / The following month, US aircraft struck North Vietnamese forces inside the Vietnamese Demilitarized Zone (DMZ) / The Siege of Khe Sanh ("Operation Niagara") involved significant efforts by Seventh Air Force / More than 24,000 tactical and 2700 Boeing B-52 Stratofortress strikes dropped 110,000 tons of ordnance in attacks that averaged over 300 sorties per day / At night, Douglas AC-47 Spooky gunships kept up fire against enemy troops / 7th AF oversaw the ongoing US air campaigns in Cambodia and Laos until the prohibition on offensive operations came into effect on 14 August 1973

The Medical Battalion was a Divisional medical unit developed to furnish medical support for the Infantry Division. Its primary mission was to organize and conduct the necessary evacuation and medical care for casualties of the Division¹. The Medical Battalion was responsible for the evacuation of ALL casualties from the Infantry Battalion and Regimental Aid Stations. If casualties could not be gathered at the Aid Stations, the Collecting Companies would remove casualties directly from the field¹. The Medical Battalion always accompanied the Division in the field¹.

Infantry Battalion and Regimental Aid Stations / If casualties could not be gathered at the Aid Stations, the Collecting Companies would remove casualties directly from the field / The Medical Battalion always accompanied the Division in the field / The Medical Battalion is organized as a "miniature" medical organization in order to maintain the best operative coordination of all the existing facilities and to give flexibility to a possible expansion of the medical service when necessary

The 2nd Infantry Regiment is an infantry regiment in the United States Army that has served for more than two hundred years / It was constituted on 12 April 1808 as the 6th Infantry and consolidated with 4 other regiments in 1815 to form the present unit / In September 1965 the First and Second battalions deployed to Vietnam, landing on the beach at Vung Tau in October 1965 / From there they proceeded to their assigned areas, Phuoc Vinh for the 1st Battalion and Lai Khe for the 2nd Battalion / The battalions initially fought as light infantry in the areas north and west of Saigon / On 2 January 1967 the 2nd Battalion officially became a mechanized infantry battalion / The 1st Battalion sustained its first major casualties of the war on 21 December 1965 when the enemy ambushed the command group of Company B as the company was moving out of Bien Hoa on routine patrol / On 25 August 1966 during Operation Amarillo a patrol from Company C, 1st Battalion was ambushed after stumbling into a Viet Cong base camp, losing 6 men killed of the 15-man patrol, total US losses in the operation were 41 killed, 45 Viet Cong bodies were found, while later intelligence indicated that Viet Cong losses were 171 men killed / During four and a half years the battalions were involved in major operations such as: Junction City, the largest operation conducted up to that time, Lam Son II, Paul Bunyan, Bu Dop (aka Battle of Hill 172), An Loc, and An Loc II and numerous other operations and small unit actions / Contact with the enemy was almost daily / When the 1st Infantry Division stood down in March and April 1970 the 1st and 2nd Battalion's colors were cased and the soldiers were either reassigned to other units in Vietnam or returned to the United States to be discharged

The 3rd Battalion, 9th Marines (3/9) is an infantry battalion of the United States Marine Corps / Formed during World War I it served until the early 1990s when it was redesignated as 3rd Battalion, 4th Marines (3/4) during a realignment and renumbering of the Marine Corps' infantry battalions, following the deactivation of the 9th Marine Regiment / The 3rd Battalion, 9th Marines was initially a subordinate unit of the 9th Marine Regiment, 3rd Marine Division, but was later operationally transferred to the 1st Marine Division as a subordinate unit of the 7th Marine Regiment where it remained until its redesignation as 3/4 / The 3rd Battalion, 9th Marines became the first battalion-sized ground combat unit to be deployed to Vietnam when they landed on 8 March 1965 in Da Nang, Republic of Vietnam / Over the course of the next four and a half years, the battalion operated from Da Nang, An Hoa and Quảng Trị and participated in over 40 combat operations, including Operation Double Eagle, Operation Buffalo and Operation Dewey Canyon / The battalion redeployed on 13 August 1969, after four years of continuous combat operations / Kilo and India companies were deployed to Bien Hoa Air Base to provide ground support, for Marine Aircraft Group 12 (MAG-12) in May 1972 / They remained at Bien Hoa until January 1973

The Combat Action Ribbon (colloquially "CAR"), is a high precedence United States Navy, United States Coast Guard, and United States Marine Corps military decoration awarded to United States sea service members "who have actively participated in ground or surface combat" / Coast Guardsmen, Navy sailors, and Marines active in clandestine, stealth or special operations are deemed eligible for consideration of the award / The U.S. Navy first authorized the Combat Action Ribbon on 17 February 1969 / The CAR is awarded to members of the Navy and Marine Corps with a rank no higher than captain and colonel, respectively

A Marksmanship Badge is a U.S. military badge or a civilian badge which is awarded to personnel upon successful completion of a weapons qualification course (known as marksmanship qualification badges) or high achievement in an official marksmanship competition (known as marksmanship competition badges) / The U.S. Army and the U.S. Marine Corps are the only military services that award marksmanship qualification badges / The U.S. military marksmanship qualification badges are awarded in three grades (highest to lowest): expert, sharpshooter, and marksman while their marksmanship competition badges are awarded in three to four grades (highest to lowest): distinguished, silver, and bronze for the U.S. Army and distinguished, gold, silver, and bronze for the Marine Corps

The Presidential Unit Citation, originally called the Distinguished Unit Citation, is awarded to units of the United States Armed Forces for extraordinary heroism in action against an armed enemy on or after 7 December 1941

The Republic of Vietnam Gallantry Cross Medal, also known as the Vietnamese Gallantry Cross or Vietnam Cross of Gallantry is a military decoration of the former Government of South Vietnam (Republic of Vietnam) / The medal was created on August 15, 1950 and was awarded to military personnel, civilians, and Armed Forces units and organizations in recognition of deeds of valor or heroic conduct while in combat with the enemy / Individuals who received the medal, ribbon, and a citation were personally cited at the Armed Forces, Corps, Division, Brigade or Regiment level / The United States military began authorizing the Republic of Vietnam Gallantry Cross in March 1968 with retroactive presentation of the decoration to 1961

The Marine Corps Expeditionary Medal is a military award of the United States Marine Corps / It was established on 8 May 1919 as the Marine Corps Expeditionary Ribbon / To be awarded the Marine Corps Expeditionary Medal, a Marine must have engaged in a landing on foreign territory, participated in combat operations against an opposing force, or participated in a designated operation for which no other service medal is authorized / After 1961, some commands permitted eligible personnel to choose between the Marine Corps Expeditionary Medal, or the Armed Forces Expeditionary Medal, depending on the nature of the operation in question

The National Defense Service Medal (NDSM) is a service award of the United States Armed Forces established by President Dwight D. Eisenhower in 1953 / It is awarded to every member of the US Armed Forces who has served during any one of four specified periods of armed conflict or national emergency from 1950 to the present / Combat or "in theater" service is not a requirement for the award

The Good Conduct Medal is one of the oldest military awards of the United States Armed Forces / The U.S. Navy's variant of the Good Conduct Medal was established in 1869, the Marine Corps version in 1896, the Coast Guard version in 1923, the Army version in 1941, and the Air Force version in 1963 / The Good Conduct Medal is

Corporal Robert Benjamin Luther honorably served in the United States Army CPL Robert Luther was deployed to Vietnam on 19 November 1969 as a Light Weapons Infantryman / CPL Robert Luther was Killed In Action on 10 May 1970 when a helicopter crashed into his unit in Quang Tri province, South Vietnam

On 10 May 1970, a U.S. Army helicopter UH-1H (tail number 67-17673) from the 237th Medical Detachment was attempting a mountaintop medical evacuation ten kilometers (6.0 miles) southwest of Cam Lo in Quang Tri Province, RVN, when hostile groundfire forced the pilot to abort his final approach and attempt a go around / For his second approach, aircraft commander WO1 Alfred J. Gaidis "dropped to the deck" a couple miles out, then screamed up the hill with 120 knots of airspeed at treetop level to try and sneak past the enemy gunners / His aircraft was caught in a .51 caliber crossfire causing him to abort a second time / As Gaidis peeled off the mountain, fuel streamed from the helicopter / The gunships escorting the medivac radioed for him to immediately set the medivac down / Gaidis' last transmission was "I think I can make it back" before the helicopter, now engulfed in flames, rolled inverted and crashed, killing all four crew members / The location where it went down on the north bank of the Cam Lo River was occupied by a column of infantrymen from "D" Company, 1st Battalion, 11th Infantry, 1st Brigade, 5th Infantry Division / The troopers had just bequeathed responsibility for Fire Support Base Fuller to an Army of the Republic of Vietnam (ARVN) unit and were making their way on foot to the Khe Gio Bridge / The flaming UH-1H hit the formation, killing two men, PFC James A. Blackmon and PFC Robert B. Luther / Both were posthumously promoted to Corporal / The lost medivac crew

Light Weapons Infantryman lack heavy weapons and armor or with a reduced vehicle footprint / Light infantry units lack the greater firepower, operational mobility and protection of mechanized or armored units, but possess greater tactical mobility and the ability to execute missions in severely restrictive terrain and in areas where weather makes vehicular mobility difficult / Light infantry forces typically rely on their ability to operate under restrictive conditions, surprise, violence of action, training, stealth, field craft, and fitness levels of the individual soldiers to compensate for their reduced lethality / Despite the usage of the term "light", forces in a light unit must carry everything they require to fight, survive and win due to lack of vehicles

The 5th Infantry Division (Mechanized) - nicknamed the "Red Diamond", or the "Red Devils", was an infantry division of the United States Army that served in World War I, World War II and the Vietnam War, and with NATO and the U.S. Army III Corps / The 5th Division was organized in December 1917 from Regular Army troops as a part of the program for the expansion of the armed forces for service in World War I / In 1968 the division was stationed at Fort Carson, Colorado, as a mechanized formation / 1st Brigade, 5th Infantry Division was dispatched to South Vietnam after the Tet Offensive to replace a U.S. Marine Corps unit / The brigade, consisting of one battalion each of infantry, mechanized infantry and armor, served there from July 1968 until 1971 defending the Vietnamese Demilitarized Zone in northern Quảng Trị Province / It was inactivated on 24 November 1992 and reflagged as the 2nd Armored Division

The 11th Infantry Brigade is an inactive infantry brigade of the United States Army / It was first formed as part of the 6th Division during World War I / It is best known for its service with the 23rd Infantry Division from 1967 through 1971 in the Vietnam War as a light infantry brigade / The 11th Infantry Brigade was deployed to South Vietnam in December 1967 due to a need for additional American troops there and during the Vietnam War served in the United States Army's 23rd Infantry Division (called the Americal Division) / For its service in Vietnam, the entire 11th was awarded the Republic of Vietnam Cross of Gallantry with Palm for 1969 and 1970 / The brigade was inactivated at Fort Lewis on 30 November 1971

The Bronze Star Medal (BSM) is a is the fourth-highest individual military award and the ninth-highest by order of precedence in the United States Armed Forces / The Bronze Star is awarded to members of the United States Armed Forces for either heroic achievement, heroic service, meritorious achievement, or meritorious service in a

A Marksmanship Badge is a U.S. military badge or a civilian badge which is awarded to personnel upon successful completion of a weapons qualification course (known as marksmanship qualification badges) or high achievement in an official marksmanship competition (known as marksmanship competition badges) / The U.S. Army and the U.S. Marine Corps are the only military services that award marksmanship qualification badges / The U.S. military marksmanship qualification badges are awarded in three grades (highest to lowest): expert, sharpshooter, and marksman while their marksmanship competition badges are awarded in three to four grades (highest to lowest): distinguished, silver, and bronze for the U.S. Army and distinguished, gold, silver, and bronze for the Marine Corps

The Presidential Unit Citation, originally called the Distinguished Unit Citation, is awarded to units of the United States Armed Forces for extraordinary heroism in action against an armed enemy on or after 7 December 1941

The Republic of Vietnam Gallantry Cross Medal, also known as the Vietnamese Gallantry Cross or Vietnam Cross of Gallantry is a military decoration of the former Government of South Vietnam (Republic of Vietnam) / The medal was created on August 15, 1950 and was awarded to military personnel, civilians, and Armed Forces units and organizations in recognition of deeds of valor or heroic conduct while in combat with the enemy / Individuals who received the medal, ribbon, and a citation were personally cited at the Armed Forces, Corps, Division, Brigade or Regiment level / The United States military began authorizing the Republic of Vietnam Gallantry Cross in March 1968 with retroactive presentation of the decoration to 1961

The National Defense Service Medal (NDSM) is a service award of the United States Armed Forces established by President Dwight D. Eisenhower in 1953 / It is awarded to every member of the US Armed Forces who has served during any one of four specified periods of armed conflict or national emergency from 1950 to the present / Combat or "in theater" service is not a requirement for the award

The Good Conduct Medal is one of the oldest military awards of the United States Armed Forces / The U.S. Navy's variant of the Good Conduct Medal was established in 1869, the Marine Corps version in 1896, the Coast Guard version in 1923, the Army version in 1941, and the Air Force version in 1963 / The Good Conduct Medal is awarded to any active duty enlisted member of the United States military who completes three consecutive years of "honorable and faithful service" / Such service implies that a standard enlistment was completed without any non-judicial punishment, disciplinary infractions, or court martial offense

The New York State Conspicuous Service Cross - The NYS Conspicuous Service Cross may be awarded to any current New York State citizen or person who was a New York State citizen while serving on federal active duty; whose entire service was honorable subsequent to the time of receipt of the citation while serving in the U.S. Army, Air Force, Navy, Marine Corps, Coast Guard or in the Army female nurse corps, and who has received a personal decoration issued by a brigade or equivalent higher headquarters. The Conspicuous Service Cross may also be awarded to any citizen of New York State, who while serving with the allied forces, received a personal decoration published in order issued by a brigade or equivalent higher headquarters

The 101st Airborne Division (Air Assault) ("Screaming Eagles") is a light infantry division of the United States Army that specializes in air assault operations / Established in 1918, the 101st Division was first constituted as an airborne unit in 1942 / During World War II, it gained renown for its role in Operation Overlord (the D-Day landings and airborne landings on 6 June 1944, in Normandy, France); Operation Market Garden; the liberation of the Netherlands; and its action during the Battle of the Bulge around the city of Bastogne, Belgium / During the Vietnam War, the 101st Airborne Division fought in several major campaigns and battles, including the Battle of Hamburger Hill in May 1969 / In mid-1968, the division was reorganized and redesignated as an airmobile division; in 1974, as an air assault division / The titles reflect the division's shift from airplanes to helicopters as the primary method of delivering troops into combat / Its unique battlefield mobility and high level of training have kept the 101st Airborne in the vanguard of U.S. land combat forces in recent conflicts

The Purple Heart was instituted in 1782 by George Washington and is the first and oldest military American

The Republic of Vietnam Campaign Medal, also known as the Vietnam Campaign Medal is a South Vietnamese military campaign awarded during the Vietnam War (Second Indochina War), the South Vietnamese government awarded the Republic of Vietnam Campaign Medal with Device (1960–) to members of the U.S. military for support of operations in Vietnam In May 1966 / The medal was awarded for two different periods of service in Vietnam / The first period for the award was from 8 March 1949 to 20 July 1954 / The second period was from 1 January 1960 to the end of the Vietnam War
